1 Significant Accounting Policies

1.1 Method of Accounting :

The financial statements have been prepared under the Historical Cost Convention in accordance with the applicable accounting standards and relevant requirements as per Income Tax Act, 1961 using the mercantile method of accounting unless stated otherwise herein after.

1.2 Revenue Recognition :

Donations are recognized on receipt(CASH) basis and accounted to the statement of income and expenditure account and appropriated to the Reserve A/c earmarked as 'Priests Medical Emergency Fund' and deposited with the Bank. The same shall be credited to the statement of income and expenditure account in the year of occurrence of medical emergencies and resultant utilization of such funds toward the said purpose.

1.3 Property, Plant and Equipment and Depreciation

Immovable tangible assets are stated at its original cost of acquisition and improvement
Moveable tangible assets are stated at its Written Down Value.

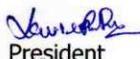
